The Financial bid is to be signed by the authorized signatory of the firm. The bids shall be opened on **15:00 Hrs of 27-03-2020** by TOC.

6. Bid Security / EMD :Rs.6,18,500/- (Six Lakhs eighteen thousand and five hundred only)in the form of BG (Annexure-II) or Demand Draft / Bankers Cheque drawn in favor of **Accounts Officer (Cash), BSNL, TS Circle Office, Hyderabad** and payable at Hyderabad from any Nationalized / Scheduled Bank, valid for 210 days from the date of opening of the Bid. The Financial quote will be rejected, if bid security is not submitted. Only MSME bidders i.e. Micro, Small & Medium Enterprises are exempted from payment of EMD (Bid security) and valid proof may be submitted to that effect for claiming such exemption.

7. Valid Provisional TSEC certificate for the product offered may be enclosed or it may be stated that applied for TESC (QF103) or for extension as the case may be and such proof may be attached. The valid TSEC certificate is to be produced within one month from the date of issue of APO.

9. Documents to be submitted offline:

10. Distribution of the Quantity: Bids shall be evaluated for 128K 4G (2FF+3FF+4FF) repluggable USIM cards. The supply order will be given to **L1 and L2 vendors (in 60:40 ratio)** with finalized **L1** price to supply the USIMs.

11. Delivery Schedule: The delivery of goods should be made to consignee (address will be given by this office) within 6 weeks (i.e. 42 days) from the date of issue of technical data.

12. The quantity of the tender may vary \pm 25% of the tender quantity.

13. The validity of the tender may be extended for one more year.

14. Validity of the PBG: 5% value of the APO + GST @ 18% is to be made in the form of **PBG valid for two years** and an agreement is to be entered at the time of issuance of the APO.

15. Payment terms–95% Payment will be released on receipt of goods by consignee and remaining 5% payment will be released after 6 months of supply of goods. For claiming 95% payment, supplier has to submit the inspection certificate (payable copy in original) issued by QA wing along with other relevant documents.

16. Liquidated Damage– This will be governed as per clause 16 of Section – 5 Part A of Empanelled tender document.

17. Material Quality and Penalties -The supplied material should be of good quality as per the specifications approved by the BSNL, failing which the materials will be rejected. The vendor will be penalized with Rs 50,000/- for the first time complaint & Rs 1 Lakh for the second time complaint & 2 Lakhs for the third time complaint and PBG will be encashed by BSNL for the complaints received fourth time or afterwards and the vendor will be black listed.

18. Warranty - The supplier shall warrant that the stores to be supplied shall be new and free from all defects and faults in materials used, workmanship and manufacture and shall be of the highest grade. The warranty of the supplied material shall be twelve months from the date of delivery of goods.

ANNEXURE-I
E-tendering Instructions to Bidders

These Special Instructions (for e-Tendering) supplement 'Instruction to Bidders', as enclosed in Sec 4 Part A of tender document.

Submission of Bids only through online process is mandatory for this Tender. For conducting electronic tendering, TS Circle, BSNL, Hyderabad using the portal <https://etenders.gov.in>

I. Tender bidding Methodology:

Sealed Bid System – Single Stage using two envelop system one for Financial bid & other for Techno-commercial documents shall be submitted by the bidder at the same time.

II. Broad outline of activities from Bidders prospective:

1. Procure a digital Signing certificate (DSC)
2. Register on Electronic Tendering System® (ETS)
3. Create users and assign rolls on ETS
4. View notice inviting Tender (NIT) on ETS
5. Download Official Copy of Tender Documents from ETS
6. Clarification to tender documents on ETS • Query to BSNL (Optional) • View response to queries posted by BSNL, as addenda.
7. Bid submission on ETS
8. Attend Public Online Tender Opening Event (TOE) on ETS Opening of Techno-commercial Part
9. View Post-TOE Clarification posted by BSNL on ETS (Optional) Respond to BSNL's Post-TOE queries.
10. Attend Public Online Tender Opening Event (TOE) on ETS Opening of Financial-Part (Only for Technical Responsive Bidders).

III. VI. Offline Submissions: The bidder is requested to submit the original BG/DD towards bid security or proof of MSME if applicable offline to DGM (S&M) CM, Room No. 301, 3rd Floor, O/o CGMT, TS Circle, Hyderabad - 500001 on or before the date & time of submission of bids specified in covering letter of this tender document, in a Sealed Envelope. The envelope shall bear (name of the work), the tender number and the words 'DO NOT OPEN BEFORE' (due date & time).

VII. Special Note of Security of Bids: Security related functionality has been rigorously implemented in ETS in a multi-dimensional manner. Starting with 'Acceptance of Registration by the Service Provider', provision for security has been made at various

stages in Electronic Tender's software. Security related aspects as regard Bid Submission are outlined below:

As part of the Electronic Encrypter™ functionality, the contents of both the 'Electronic Forms' and the 'Main Bid' are securely encrypted using a Pass-Phrase created by the Bidder himself. Unlike a 'password', a Pass-Phrase can be a multi-word sentence with spaces between words (e.g. I love this World). A Pass-Phrase is easier to remember, and more difficult to break. It is recommended that a separate Pass-Phrase be created for each Bid-Part. This method of bid-encryption does not have the security and data-integrity related vulnerabilities which are inherent in e-tendering systems which use Public-Key of the specified officer of a Buyer organization for bid-encryption. Bid-encryption in ETS is such that the Bids cannot be decrypted before the Public Online Tender Opening Event (TOE), even if there is connivance between the concerned tender-opening officers of the Buyer organization and the personnel of e-tendering service provider.

Typically, 'Pass-Phrase' of the Bid-Part to be opened during a particular Public Online Tender Opening Event (TOE) is furnished online by each bidder during the TOE itself, when demanded by the concerned Tender Opening Officers who will open the bid. Else Tender Opening Officer may authorize the bidder to open himself.

There is an additional protection with SSL Encryption during transit from the client-end computer of a Supplier organization to the e-tendering server/ portal.

VIII. Public Online Tender Opening Event (TOE): ETS offers a unique facility for 'Public Online Tender Opening Event (TOE)'. Tender Opening Officers as well as authorized representatives of bidders can attend the Public Online Tender Opening Event (TOE) from the comfort of their offices. For this purpose, representatives of bidders (i.e. Supplier organization) duly authorized are requested to carry a Laptop and Wireless Connectivity to Internet.

Every legal requirement for a transparent and secure 'Public Online Tender Opening Event (TOE)' has been implemented on ETS. As soon as a Bid is decrypted with the corresponding 'Pass-Phrase' as submitted online by the bidder himself (during the TOE itself), salient points of the Bids are simultaneously made available for downloading by all participating bidders. The work of taking notes during a manual 'Tender Opening Event' is therefore replaced with this superior and convenient form of 'Public Online Tender Opening Event (TOE)'. ETS has a unique facility of 'Online Comparison Chart' which is dynamically updated as each online bid is opened. The format of the chart is based on inputs provided by the Buyer for each Tender. The information in the Comparison Chart is based on the data submitted by the Bidders in electronic forms. A detailed Technical and/ or Financial Comparison Chart enhances Transparency.

Detailed instructions:

ETS has a unique facility of a detailed report titled 'Minutes of Online Tender Opening Event (TOE)' covering all important activities of 'Online Tender Opening Event (TOE)'. This is available to all participating bidders for 'Viewing/ Downloading'. There are many more facilities and features on ETS. For a particular tender, the screens viewed by a Supplier will depend upon the options selected by the concerned Buyer.

NOTE: In case of internet related problem at a bidder's end, especially during 'critical events' such as – a short period before bid-submission deadline, during online public tender opening event, during e-auction, it is the bidder's responsibility to have backup internet connections. Any such demand made on the bank shall be conclusive as regards the amount due and payable by the Bank under this guarantee where the decision of the BSNL in these counts shall be final and binding on the bank. However, our liability under this guarantee shall be restricted to an amount not exceeding the "B. G. Amount".
