**SECTION II**  
**Instructions to Bidders**

**1. ELIGIBLE BIDDERS:**

The following types of bidders are eligible

- a) Proprietorship (Power of Attorney with notary signature is to be enclosed if proprietor is not signed )
- b) Partnership (power of Attorney with all partners signature along with notary signature & partnership Deed should be enclosed)
- c) Private Limited Company ( Name & Capacity of the person who has signed on the bid)
- d) Public Limited Company (Power of Attorney with notary signature, copy of certificate of incorporation Memorandum & articles of Association to be enclosed) .
- e) The bidder should furnish the information of tender's profile at Annexure – II.

**2. PERIOD OF VALIDITY OF BIDS**

Bid shall remain valid for **One year** from the date of opening of bids prescribed by the purchaser. Any bid valid for a shorter period shall be rejected by the purchaser being non-responsive.

**3. Bid Documents:**

As part of bid documents establishing the bidder's eligibility, the bidder shall furnish the following documents.

**4. - (b) All pages of Limited Tender documents should be duly signed with stamp by authorized person .
- (c) It may be sent either by registered Post or delivered in person in the above mentioned address. The responsibility for ensuring the tenders to deliver in time would vest with the bidder.
- (d) If the envelope is not wax / tape sealed properly as mentioned, the bid is liable to be rejected.
- (e) The full name and address of the Tenderer should be written on bottom left hand side corner of the sealed cover.

**5. EVALUATION AND COMPARISON OF SUBSTANTIALLY RESPONSIVE BIDS:**

- 1. **Price Bid Evaluation:**The bids will be evaluated based on the lowest Grand Total quoted by the bidder in PRICE BID section –IV ie. Sum of price quoted for all items for 10000 to 20000 Qty.

**6. PURCHASER’S RIGHT TO VARY QUANTITIES AT THE TIME OF AWARD:**

- (a) BSNL will have the right to increase or decrease up to 25% of the quantity of goods and services specified in the schedule of requirements without any change in the L-1 unit price or other terms and conditions at the time of award of contract.

## SECTION III

### GENERAL CONDITIONS

#### 1. Scope of work :

- a) The successful bidder will be required to Printing and Supply of Marketing Material items like Pamphlets, Brochures, Stickers, Posters and Application forms etc. to BSNLO/o PGM HTD, Hyderabad for a period of one year at given locations.
- b) The concept/Art work meant for Printing and Supply of Marketing Material items like Pamphlets, Brochures, Stickers, Posters and Application forms etc will be supplied by AGM(Mktg& CSC)CM either through email or in the form of soft copy (CD) hence, the same should be printed as per the requirement in good quality.
- c) The uniformity on paper and print quality shall be maintained.
- d) The vendor should carry out the work within **Five days** from the date of issue of work order.
- e) Any Expenditure pertaining to given work the charges for transportation, labour etc, should be borne by the vendor.

#### 2. Inspections :

1. On completion of the work, AGM(S&M)CM or his/ her authorized representative will carry out the physical inspection w.r.t. quality of the work and if not satisfied, it should be reprinted and supplied as per instructions of work order.

#### 3. PERFORMANCE SECURITY:

- 3.1 The Successful bidder shall furnish performance security in the form of Bank guarantee or DD valid for a period of one year to the purchaser for an amount equal to 10% of the work order within six days from the date of issuing of LOI to the bidder.
- 3.2 The Security Deposit thus kept under the custody of the BSNL, Hyderabad will not fetch any interest during the period of validity of the contract.
- 3.3 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete its obligations under the contract.
- 3.4 The Performance Security deposit will be discharged by the purchaser after three months from date of completion of tender validity. and supplier's performance obligations including any warranty obligations under the contract.

#### 4. PAYMENT TERMS:

- a) **Mode of payment:** The necessary payment will be made through NEFT/RTGS from the office of **AO(Pay) Main,O/o PGM HTD, BSNL, Adarshnagar , Hyderabad** after submitting the delivery Challan, bills in duplicate along with advance stamped receipt, and proof of completion of the work.
- b) No advance payment in any form will be made by the BSNL.

#### 5. Penalty for delay:

- a) The work must be completed within the specified period.
- b) Extension will not be given except in exceptional circumstances.
- c) If the tenderer fails to complete the work within the stipulated period of FIVE days, the purchaser shall be entitled to recover 1% of the payable value upto two weeks of delay and part thereof for a period upto to one month.
- d) The maximum penalty for the delay can be 2% of the payable value for the delayed quantum of work.

## **6. TERMINATION OF CONTRACT**

- a) If the agency/contractor fails to complete the work within the period(s) specified in the contract or any extension thereof granted by BSNL OR
- b) If the agency/contractor fails to perform any other obligation(s) under the contract OR
- c) If the performance is found unsatisfactory due to the negligence of the agency/contractor BSNL, without prejudice to any other remedy, for breach of contract rescind the contract and the security will be forfeited.
- d) Depending upon the severity of negligence, BSNL reserves the right to blacklist the agency/contractor from further participation in any of BSNL tenders/contracts. The decision of BSNL shall be final in this regard.

## **7. TERMINATION FOR INSOLVENCY**

BSNL may also by giving written notice and without compensation to the agency terminate the contract if the contractor becomes unwilling, bankrupt or otherwise insolvent without affecting its right of action.

## **8. FORCE MAJEURE**

If any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions. Strikes, lockouts or act of God (Hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such events be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such non- performance or delay in performance under the contract shall be resumed as soon as practicable after such an event may come to an end or cease to exist, and the decision of BSNL as to whether the supplies have been so resumed or not shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding sixty days either party may, at his option terminate the contract.

## **9. ARBITRATION**

9.1 In the event of any question, dispute or difference arising under the agreement or in connection there with (except as to matter the decision to which is specifically provided under this agreement), the same shall be referred to sole arbitration of the PGM, BSNL. In case his designation is changed or his office is abolished then in such case to the sole arbitration of the officer for the time being entrusted whether in addition to the functions of the PGM, or by whatever designation such officers may be called (hereinafter referred to as the said officer) and if the PGM or the said officer is unable or unwilling to act as such, then to the sole arbitration of some other person appointed by the PGM or the said officer. The agreement to appoint an arbitrator will be in accordance with the Arbitration and Conciliation Act, 1996.

9.2 The arbitrator may from time to time with the consent of both the parties enlarge the time frame for making and publishing the award. Subject to aforesaid arbitration and conciliation Act, 1996 and the rules made there under, any modification thereof for the time being in force shall be deemed to apply to the arbitration proceeding under this clause.

### **SET OFF**

Any sum of money due and payable to the contractor (including security deposit refundable to him) under this contract may be appropriated by BSNL and set off the same against any claim of BSNL for payment of a sum of money arising out of this contract or under any other contract made by contractor with BSNL.

**13. PURCHASER'S RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL BIDS:**The purchaser reserves the right to accept or reject any bid and to annul the bidding process and reject all bids, at any time prior to award of contract without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds for the Purchaser's action.

**14.** The bidder will verify the genuineness and correctness of all documents & certificates, including experience /performance certificates, issued either by the bidder or any other firm/associate before submitting them in the bid. The onus of proving the genuineness of the submitted documents would rest with the bidder. As per the requirement of the tenders conditions if any document/paper/certificate submitted by the participant bidder is found to be false/fabricated/tampered/ manipulated at any stage during bid evaluation or award of contract, then the bid security(EMBG) of the bidder would be forfeited and the bidder would be disqualified from the tender. The action would also be taken for banning business dealings with the defaulting firm. In case the contract has already awarded to the bidder then PBG would be forfeited. & the contract would be rescinded/annulled and BSNL would be at liberty to procure the ordered goods and services from any other source at the risk and cost of the defaulting bidder. The action would also be taken for banning business dealings with the defaulting firm. To obviate any possibility of doubt and dispute and maintain the veracity of the documents/papers/certificates, the documents conforming to eligibility part will be submitted by the participant bidder and signed by the authorized signatory will be opened at the time of tender opening. These papers will be signed by the In charge of the tender opening team and the authorized representative of the bidder company and will be kept preserved along with the original bid and in case of any dispute, this paper will be treated as an authentic one.
